Whereas, Participant desires to participate in the Parade.

Now, therefore, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and in consideration of Participant participating in the Parade, and the undersigned having the authority to sign this agreement, and intending to be legally bound, the parties agree as follows:

1. The Participant covenants that it shall not sue **Indiantown Chamber of Commerce and the Village of Indiantown** or any of their respective directors, officers, employees, or agents for any action, claim or otherwise arising out of Participant's participation on the Parade; and further

2. Participant does hereby indemnify Stuart Main Street Association, Inc., Indiantown Chamber of Commerce and the Village of Indiantown, their respective directors, officers, employees, and agents, against all claims brought against Indiantown Chamber of Commerce and the Village of Indiantown arising from, or in any way attributed to, any negligent or willful act or omission of Participant, and which relates to or arises from the Parade. This indemnification shall include a proper defense of all claims of damages whatsoever as well as any attorney's fees and costs incurred by Indiantown Chamber of Commerce and the Village of Indiantown and shall include all those at all appellate levels.
